- ACT program - Section 3 18 classes (Cost = \$2195)**
Tuesdays -- 3:30 -- 5:30 PM. Students take the ACT in both December and April
9 summer ACT classes (June 27 to August 22) -- once a week for nine weeks during the summer
9 classes (September to April) -- once or twice a month **weekend** review classes for six months thereafter
One hour homework per class mandatory: Total instruction = 36 hours
